

Giving Account® Administrative Fees

Fidelity Charitable® provides donors with best-in-class support and service in facilitating their giving. Fees associated with a Fidelity Charitable Giving Account are typically less than 1% of the annual account balance, which is competitive with other donor-advised fund (DAF) programs and typically better than giving through a credit card or private foundation.

Fidelity Charitable uses two standard administrative fee schedules based on the balance of the Giving Account. These fee schedules are mutually exclusive and will not be used in combination.

Tiered Fee Schedule

For Giving Account balances under \$5 million:

Account Balance	Administrative Fee
First \$500K	60 bps
Next \$500K	30 bps
Next \$1.5M	20 bps
Next \$2.5M	15 bps

Flat Fee Schedule

For Giving Account balances over \$5 million:

Account Balance	Administrative Fee
\$5M – \$10M	19 bps
\$10M – \$20M	17 bps
\$20M – \$35M	15.5 bps
\$35M – \$50M	13.5 bps
\$50M – \$75M	12 bps
\$75M – \$100M	11.5 bps
Above \$100M	Please call

In addition to administrative fees, Fidelity Charitable assesses investment fees on the mutual funds where donations are invested. Visit FidelityCharitable.org for more information on our investment options and associated fees.
