



Investment options to meet your giving goals

A Giving Account® at Fidelity Charitable® lets donors recommend how their contributions are invested, giving the assets the potential to grow tax free—which may ultimately result in additional dollars for charitable grants. Contributions can be allocated among a variety of investment options to help meet donors' investment goals for their Giving Account.®

Asset allocation pools

Asset allocation pools are for donors seeking diversification among multiple asset classes in a single investment pool. The funds underlying these pools have a mix of stocks, bonds, and short-term instruments that range from a higher equity allocation mix to a lower equity allocation mix.

Single asset class pools

Single asset class pools are for donors looking for exposure in a single asset class or who wish to build a custom strategy combining single asset class pools in their Giving Account.

For even greater investment flexibility

Charitable Investment Advisor Program

This program is for donors with a Giving Account balance greater than \$100,000 who would like to nominate their investment advisor to manage assets contributed to Fidelity Charitable.

Sustainable and impact investing pools

Sustainable and Impact Investing pools are for donors who seek strategies that consider social and environmental factors, while also emphasizing financial returns.

Charitable Legacy Pool

The Charitable Legacy Pool is for donors seeking an “all-weather” asset allocation pool with exposure to both traditional and non-traditional asset classes.

Charitable DonorFlex Program

This program is for donors with a Giving Account balance greater than \$5 million who desire flexibility beyond what the investment pools offer. DonorFlex allows donors to recommend that their Giving Account assets be invested in hedge funds, private equity funds, mutual funds, treasuries and ETFs.

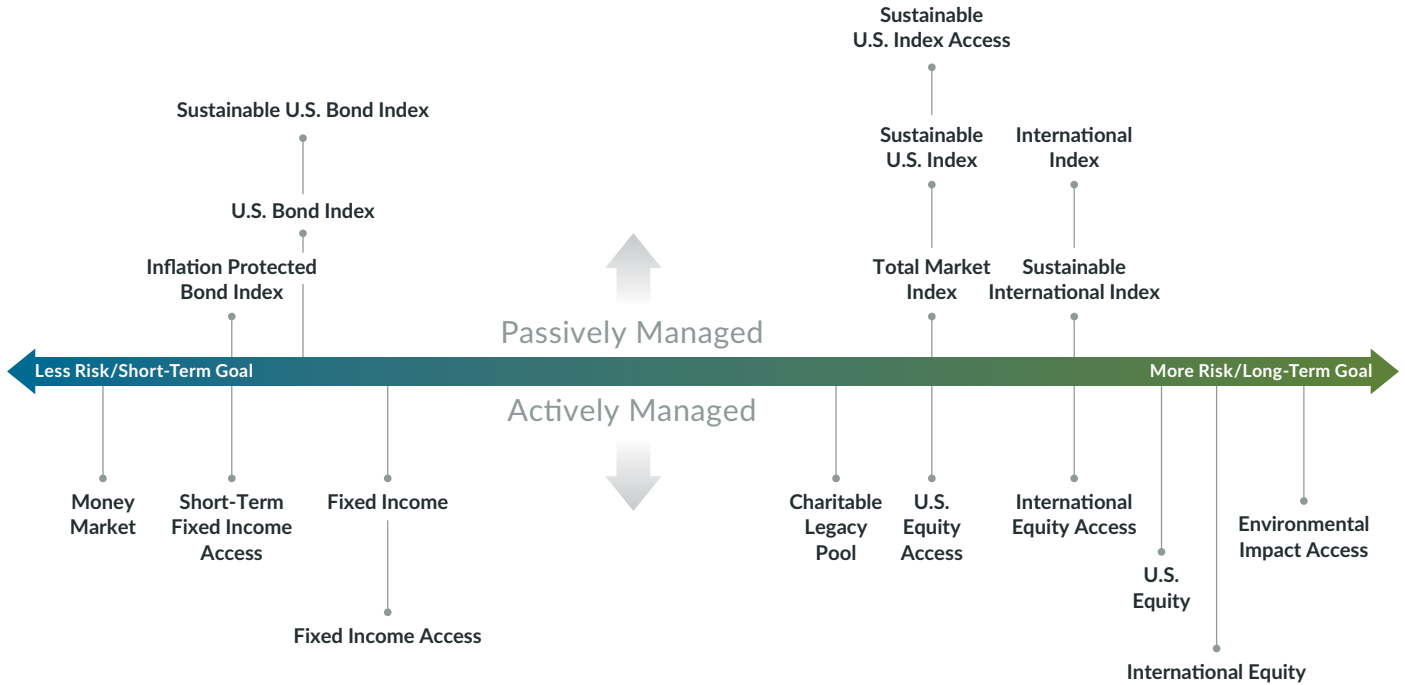
